Tuition & Registration

Tuition Policies:

1. Tuition is always the same amount from the first of the month to the last of the month, regardless of the number of classes in a month or studio closures.
2. Students enrolled in automatic payments will be charged monthly tuition unless an add/drop form is submitted in writing before the first of the month.
3. Tuition payments are due on the first day of each month. After the 10th, a \$20 late fee will be added to regular tuition. If fees are unpaid after the 20th of the month, the student will no longer be able to attend classes until outstanding fees have been paid in full.
4. The tuition rates listed reflect the total number of classes attended per week by all members of a single family.
5. Monthly classes can be paid by two plans: individually, on a “drop-in” basis, or monthly tuition. The choice can be made annually, at time of registration.

Non-Payment of Tuition:

West Linn Dance Center, at its discretion, may dismiss any student if his/her tuition is past due. No student will be allowed to participate in our year end show or rehearsal if his/her tuition is past due.

Dress Code

It is important that your child wears clothing that is made for dancing. The appropriate shoes, tights, and leotards are necessary for the development of proper dance technique. Please ask a WLDC staff member if you are unsure of your child’s dress code.

Conduct

All staff, students, and parents are expected to conduct themselves in a manner which promotes mutual respect and a positive learning environment. In the event a student is disruptive, a time out may be used. If disruptive behavior continues, the parent will be called to help find a solution. West Linn Dance Center reserves the right to decline service, at will.

Missed Classes

A student can make up a class that is missed due to illness within 2 weeks. Contact the instructor for the appropriate make up class. There are no refunds for missed classes or studio closures.

Recital

Costume

There will be a costume cost of \$45-\$75 for any student who wishes to participate in the end of the year recital. Also, students will need to purchase makeup, new tights and shoes before to the recital. Alterations may be necessary and must be done prior to picture day and at the student’s own cost.

Tickets

There is a fee for tickets due to the expense of renting the theater. Ticket sales will begin before the recital month.
